




Ranking of international economic universities by Chinese Ministry of Education

Fellowship Programme for foreign specialists InteRussia

The programme has been implemented at the premises of St Petersburg State University of Economics (UNECON) in cooperation with The Alexander Gorchakov Public Diplomacy Fund since 2023.

Partners of the programme: the Russia-ASEAN Business Council, ''Russian Energy Agency'' (REA) by the Ministry of Energy of the Russian Federation, Global Energy Association and TV BRICS International Media Network.

The programme includes lectures by energy experts, representatives of Russian energy companies, case studies, visits to government agencies, industrial enterprises and major energy infrustructure facilities in Saint Petersburg and Moscow (Rosseti, Gazprom, Russian Ministry of Energy, Kinef oil refinery, State Atomic Energy Corporation Rosatom and other facilities).

The programme is aimed at specialists with relevant degree and work experience in the field of economics, management and technology in the energy sector.









Youth Day as part of SPIGF

Youth Day has been held for ten years already as part of St. Petersburg International Gas Forum (SPIGF) which is one of the main and the most esteemed industry events. The project is implemented by UNECON with the support of Gazprom and other partner companies. It provides a high-level platform for discussion about the future of the world energy between experts and young generation. Over these years, about 1800 young people from 60 countries took part in this project.

A rich programme of the Youth Day usually includes team building, various workshops from leading energy companies, participation in SPIGF Plenary Meeting, visit to SPIGF exhibition, off-tie meeting with top experts and heads of energy companies, business game, cultural programme and entertaining activities.

Master's and PhD students under 35 years old who speak English and have interest in energy sphere are invited for participation in the Youth Day of SPIGF.









Energetika XXI

The conference "Energetika 21" has been held at UNECON annually since 2007. During the last sixteen years more than 4000 experts in the field of energy economics from Russia, the EU, the US, China and Central Asian countries took part in the conference. Nowadays Energetika 21 is an important international platform to address recent developments in the energy sector on a global basis with special focus on Russia, and the topics of common global interest such as the unanimously agreed targets of the Paris Agreement (PA) and the various approaches to achieve them from global, regional and local perspectives.





Eurasian Economic Perspective

The Annual International forum "Eurasian Economic Perspective" has become one of the main congress platforms for conducting a dialogue on the problems of Eurasian integration, as well as exchanging views on the prospects of Eurasian inter-state cooperation. Traditionally, it unites representatives of the Eurasian Economic Commission, Eurasian Development Bank, CIS Executive Committee, Union State of Russia and Belarus, ministries of the Russian Federation, universities of Eurasian space, economists, politicians and public figures, business community.

BUDDY PROGRAM


Buddy Program is an association of highly motivated Russian students whose goal is to help internationals to get acclimated in Russia and become a part of community. Buddies take care of:


